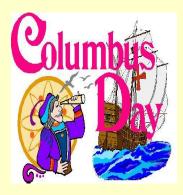

## **Homeowners Association Board News**

Wow what a year this has been, tumultuous times for sure around this great nation, but luckily things are going great in our beautiful community. As we have reported to you previously, this BOD has been working very well together to get things accomplished, all for the benefit of our residents and community. We recently informed you of the work that is required to replace the pool filtration system at the North Clubhouse Pool. We are happy to report that the vendor that was selected for that project has already applied for permits and we expect that work to begin in 6 to 8 weeks. During that time the pool will be closed for a few weeks, but we promise to have it back open as soon as possible. During that time please enjoy the South Pool which will remain open for your enjoyment.

Due to a financial windfall for the community, we are very happy to announce that we will still be able to move forward with the project to replace and expand the covered patio area at the Clubhouse Pool and we will be able to finally replace the roof on the Main Clubhouse, to once and for all put a stop to the myriad of leaks that we are constantly fixing.

Thanks to renewing our agreement with Xfinity Communications for access to our community, we will be receiving \$63,000.00 from Xfinity to be used for community projects. This is the same agreement that was entered into with Xfinity 10 years ago that provided us with the same amount of money to help pay for our clubhouse remodel project.

This very active BOD has already obtained BIDS for all of the work and have selected vendors for the patio project. We have also secured three bids for the roofing project and will be selecting that vendor soon.

Its great that we will be able to get all of these projects done without an impact to our budget!

# Community News - Respecting the Rules

Many times residents will invite guests to the pool to enjoy a party and those guests who are not familiar with State Law and our community rules will bring a glass item such as beer or wine to the pool. It is the resident's responsibility to make sure that their guests do not have any glass items. Ultimately the homeowner will be held responsible. We have also had many residents say that they were not aware of the rule and therefore shouldn't be held accountable. Ignorance of our rules or by law restrictions is not an acceptable excuse. As a homeowner it is your responsibility to be aware of both. Besides numerous signs posted around each pool area that state NO glass allowed, all of our rules and restrictions are available on our website for download or review.

Please help us to maintain a safe environment and do not bring any glass items to the pool areas. As a resident, if you see another resident violating this rule, you can either kindly remind them of the rule or you can contact the WW5 office and leave a message indicating the date and time that a resident had glass at the pool so we can address it with the resident.

- 2) Home Modifications Any home modification such as; the installation of a fence, altering your driveway, any construction such as adding a walkway, adding a room, pouring a concrete patio, etc... requires Board approval BEFORE you begin the work.
- 3) Parking on the Grass Parking your vehicle on your lawn, even for a short time is also prohibited. If you are having a party with a lot of guests that will not fit on your driveway or street please have them park at one of the pool areas instead of parking on your grass. If a vehicle is found to be parked on your lawn you risk receiving a code violation and a fine.

Now that we are in PHASE II in Broward County, we can begin renting the CLUBHOUSE again at 50% capacity. If you are interested in renting the clubhouse for an upcoming event, please contact Robyn in the main office to reserve your date!

Please be mindful that you MUST adhere to the limited capacity and social distancing guidelines during your event.
